INVITATION TO BID For Contract No. 2023-03

2023 - 2024 Sewer Lining Program

Notice is hereby given that the Flagg Creek Water Reclamation District (District), will receive sealed bids at the District Main Office, 7001 Frontage Road, Burr Ridge, Illinois 60527, until **11:00 a.m., Central Time, February 22, 2023**, at which time and place the bids will be publicly opened and read aloud.

The proposed work is officially known as the **2023 - 2024 Sewer Lining Program**. The work for which bids are to be received consists of a Detailed Scope of Work to include an estimated 8,753 Linear Feet of 8-inch sewer with an estimated 100 service reconnections, which is contained within this Contract. Bids are further to include all applicable sewer cleaning, flow bypassing, televised inspections, protrusion removal, cured-in-place lining, service reconnections, and any and all additional work to complete this defined scope. Additional work may be requested on an as needed basis, specifically for lining of various diameter sewers ranging from 8-inch sewers and in some instances sewers with a diameter up to 30 inches that may require rehabilitation, during the one-year term of this Contract. **The total estimated cost of this Contract is \$425,000.00**

Proposals must be submitted on proposal forms as provided in the Contract Documents. The bid deposit for a proposal is **\$10,000.00**, in the form of a certified check, a cashier's check, or a bid bond, made payable to the Flagg Creek Water Reclamation District. In addition to the signed and completed proposal and the bid deposit, Bidders must also submit a signed and completed Affidavit on the form included in the Contract documents. Failure to submit these materials may cause the bid to be rejected.

The successful Bidder to whom the Contract will be awarded shall sign the Contract, furnish a Performance and Payment Bond in an amount equal to 100% of the TOTAL BID AMOUNT as indicated in the Proposal, and certificates of insurance along with any insurance policies required by the Contract Documents within ten (10) days from the date of the Notice of Award. The amount of the check or bond shall be forfeited to the District if the Bidder neglects or refuses to enter into a Contract or fails to furnish the appropriate Performance and Payment Bond and insurance after his bid has been accepted.

The Contract Documents for use by prospective Bidders may be obtained at the District Main Office upon payment of **\$30.00**. The payment is non-refundable and is payable to the Flagg Creek Water Reclamation District in the form of cash, check, or a money order.

The District reserves the right to reject any or all bids that are submitted, or to advertise for new bids. The District reserves the right to defer the acceptance of any bid and the execution of a Contract for a period not to exceed ninety (90) days after the date of opening the bids.
