Chairman Stade called the meeting to order at 10:40 A.M.

Chairman Stade asked if any Officer had any issues, comments or corrections to the December 18, 2020 Board of Local Improvements meeting minutes as submitted. No comments were raised. Votes recorded: Walsh-Aye, McGoldrick-Aye and Stade-Aye. The motion carried.
